### **Vega Farmers Market Fee Schedule:**

\$50 Membership per year payable to Moonlight Organic Farm.

**Stall Fees:** all fees must be paid in advance of your market participation.

**Full Season:** (October 2012 –March 2013) or (April 2013– September 2013)  
**\$150 per week** for Single Stall per season.

**Consignment will be negotiated if unable to attend 5 days a week.**

**Minimum attendance of 26 weeks is required for this fee.**

**Full Payment of \$3950 per stall is required for 6 months per season.**
